
#### CHANGE OF ADDRESSES




#### ACHIEVEMENT PROGRAM



To the "Order Board" Editor:

It appears that there is a dispute over the procedures followed during the recent election of Cajon Division officers. The dispute has strong overtones of petty power politics and mutual distrust among certain Division members. I want to say two things about the situation.

First: Model railroading is supposed to be fun. The NMRA and its components exist solely to enhance the fun and strengthen the hobby. There is absolutely no place for power politics nor "dirty tricks". Those who stoop to such practices, for whatever reason, should be told by the rest of the membership that while the individuals are welcome, those practices are not. No formal vote of censure is needed; we can doit during individual contact with those involved.

Second: It seems to me that the real culprit in this situation is not any individual or group of individuals, but the Division Bylaws. They are unclear about election procedures. These procedures need not be elaborate, but they do need to be clearly defined. The ByLaws are deficient in other respects also; for example, the descriptions of the functions of the officers are both incomplete and conflicting. I propose that we appoint an ad hoc committee to study the ByLaws and develop amendments to be submitted to the members for approval. I further suggest that no action toward another election be taken until this committee has completed its work.

In other words, when the train is in danger of derailing, lets look to be sure the track is in good condition!

#### OPEN LETTER TO THE DIVISION

Well, the elections are over or are they? Eight people ran for Superintendent and Assistant and only 2 won! The backers are very "disgruntled" and have called FOUL! On one hand, I have been accused of Stuffing the Ballot Box and on the other hand they are saying, "NO we are not saying that!" So...it goes from this to collusion with the Ballot Chairman. Supposedly, he was to keep me informed of the Election results periodicly, so that I could go out and campaign harder.... THIS IS ALL TRASH! And after, I was asked to resign or I would get run over by a few powerful people in the Division that had a lot of pull in the higher echelons: WELL, I have a membership card too...and I have a LITTLE PULL and so does each and every member that pays his dues! Just write or phone the Elected Officers of this Association and voice your views. I have nothing to hide, but this clique has and it will eventually all come out! There could be 5, 10 or even 15 elections, but the ballot will be protected...each and every time from duplication and ballot box stuffing! I feel the membership has a right to know what is going on and why. The PCR knows it cannot by-pass the membership either. Please let the PCR hear from you. The opposing side has written in and you can do the same. Even a postcard will do. Also, letting them know which way you voted. My votes tallied to 61....and if you let the PCR know...these CLIQUES cannot by-pass US and impose THEIR WILL UPON US THE DIVISION....we can remain a strong Division.

The difficult part of all this, is that some members and non-members are believing this trash without proof being brought forth. They are taking GOSSIP FOR FACT. These are the same people that have NOT HELPED THE DIVISION FROM DAY ONE. And where were they when we needed them? They feel they have done their part in the past and "now its time for others to do theirs"...But, it seems they are pitching in with all they got to CRITICIZE AND SPREAD MALICIOUS GOSSIP!

I have stepped on alot of toes to get this Division where it is today because I did not do as some people saw fit and some members have taken offence. I apologize to those of you that cannot take constructive criticism or work for our Division as a COMPLETE BODY with the purpose of MODEL RAILROADING BEING FUN. When we have lost sight of that, then we have lost the whole purpose of why we are a Division of the PCR-NMRA.

This is my statement of DEFENSE! Which is a shame one has to do constantly...but it is to the best of my knowledge what I know at this time...(I am sure something else will develope after this printing!).....I wish to state that I have PAID FOR THE PRINTING OF THIS ARTICLE MYSELF......and that anything I have done for the Division is at my own expense and I am not compensated for it.....I trust this will enlighten any of you that have just heard bits and pieces of this whole thing and will understand that I am at this time defending what others are trying to break down: not only MY integrity, honesty and credibility but that of my family.

#### "MY SINCERE APOLIGIES"

I wish to extend an appology to the Division and to HARPERS HOBBY SHOP for the delay in the printing of this ORDER BOARD. But circumstances beyond my control prevented its delivery. 

HI GANG..... Hope you and yours had a good holiday season. Glad you could join us again. Let's talk about a couple of things we can do to dress up plastic structures.............Wait a minute, before you go away....consider this: Plastic still makes the best looking brick material we've got, and all of us, even modelers of the early west can use a few brick buildings. According to my books, even the smallest of early Colorado towns had one or more brick buildings... In the 1880's and before.

OK.....if you're still with me, let's give it a try! "Con-Cor's"Courthouse Square Series, Lytler & Lytler, Magnuson Models, AHM and others all offer some very nicely detailed plastic(or resin) brick buildings suitable for modern as well as period use, but they have one drawback: look like plastic. To overcome this, some major repainting is required and that's what I want to talk about. Many of the above-mentioned kits have a small scale-sized brick ..... these seem to look best when painted red. First, spray the walls with Pactra's "Brick Red" either their spray can or with an airbrush. Allow the walls at least 24-hours to dry before proceeding. Nest, obtain some Floquil Polly-S Concrete or Reefer White (The choice is yours. Concrete results in a subdued red color; white emphasizes the redness of the brick...be sure it's Polly-S...). Taking each wall separately, brush on a liberal amount of your Polly-S paint.....now quickly rub or wipe it off with a paper towel, leaving the color only in the "motar lines" the brick.....got it? The idea is to color those motar lines with a color that contrasts red bricks. Try both the concrete and the white on a piece of scrap and select the one like best.....perhaps, half concrete and half white would suit you..... use all three combinations, depending on the building. When you wipe the Polly-S off the brick walls, wipe in vertical direction.... The wiping action will tend to streak the walls very realistically. Now, you can spray paint your window castings and trim material and assemble per kit instructions ...

YOU'LL NOTICE that some plastic brick building kits have a much larger brick material for walls....Often these look better if they are painted to represent a gray cut stone rather than red brick. To do this, first spray paint the walls with a flat white (Pactra's Flat White will do nicely, or you can use Floquil). After the walls dry, brush on some Polly-S Concrete, erally, and wipe off with a paper towel ... again, WIPE VERTICALLY! Now, you can dry-brush eaks on the walls using a darker gray, such as Floquil's Reefer Gray, but be subtle. end result is a weather-beaten gray stone color.

AFTER YOUR BUILDINGS ARE ASSEMBLED, you can really enhance them with signs and posters. Vintage Reproductions and Irv Shultz both make some great dry-transfer sign sets for buildings....and a good source for posters is Reader's Digest and other magazines.....stick with smaller ads HO posters. When the buildings are complete, consider adding some pastel chalk to the walls as a final weathering touch.....Grumbacher's Raw Umber seems to be the best choice for Just scrape some into a powder and brush it on in appropriate places.
