Cajon Div Meet Oct 12

Keep Sunday, October 12 open for a day of family railroad fun as Chuck and Marjorie Valenzuela co-host the Cajon Division Fall Meet at their Railroad Ranch in Ontario. The site is located at 1250 West Philadelphia Street, between Oaks and Magnolia Avenues. Take the Pomona Freeway (Route 60) and exit at Mountain Avenue, head North one block to Philadelphia, turn West and drive two blocks to the Ranch. Park on the street.


A full slate of events starts at 11:00 am and ends at 4:00 pm. In between you'll enjoy:

-- Riding two 14-inch gauge passenger trains that once graced the rails of Knott's Berry Farm. These trains, now fully restored, offer first class service on a one-third mile loop at the Ranch.

--Riding two 18-inch gauge Pacific Electric "Venice Cars." These scaled-down red cars are enclosed and self-propelled. Once in operation at Legg Lake during the 1940's (with some car parts dating back to the Venice Railway c. 1906), these cars ply their own line at the Ranch. Restoration, while not complete, is well advanced and the cars are available for service.

--Swap Tables featuring a little to a lot of everything from the closets and garages of some of America's legends in the model railroad swap table society. Bring your own table, it's free with admission. Note: Persons bringing prototype Rock Island cars and locomotives must show proof of ownership.

--All day railroad films from Union Pacific, Southern Pacific, Santa Fe, Alaska Railroad, Burlington Northern, Colorado Fuel & Iron Corp., General Motors and Kalmbach. At last count 15 films were scheduled for your enjoyment.

--Rare displays of toy and model railroad equipment. Four rooms of scale and tin-plate railroad items including some one-of-a-kinds. All eras and scales are represented. In addition there are displays of antique toys and dolls.

--Picnic facilities for your dining enjoyment. Bring your own food, drinks and blanket and we'll supply the bar-b-ques, trees and grass. Cont. on Page 2

In these times of inflation the Cajon Division brings you more for your dollar...and that's your cost. PCR families (up to 6 persons) are one dollar. Prototype Tours Coming

The Division is negotiating two more of its highly popular prototype railroad yard tours. The next tours tentatively have been scheduled for <u>December 6</u> (Amtrak Los Angeles Coach Yard and Roundhouse) and <u>April 25</u>, 1981 (Santa Fe Barstow Classification Yard).

Both tours will be in the four to five dollar price range and will include charter bus service. And as usual, slots on these tours will be limited and probably sold-out well before the tour date.

Tour schedules and reservation forms will be available about six weeks prior to the tours. All requests for these forms will be assigned a priority number as they are received. The forms will then be returned to the requestors in batches with the first requests receiving first attention.

Cajon Div Auction Nov 15

Admission to the Auction is \$1.00. Items actually sold will be assessed a ten percent (10%) fee based on the ultimate selling price. No fee will be charged to items not sold.


Once again the Cajon Division will pull out all the stops to sell your model railroad treasures, including books and magazines. There's a five dollar minimum per item or lot, so bring lots of cash and energy. Nearly four thousand dollars of items were auctioned last year, let's go for more this year.

This is your chance to buy and sell railroad hobby items in an atmosphere quite different than the usual swap meet with the established minimum bid price the seller sets a floor for his profit and the buyer knows the least possible price he can offer for the available item.

If you have items to sell, plan on bringing an open top box or card-board mounting sheet for each item (except books & magazines) plus a felt-tip marker for identifying the items on the auction cards.

If you plan to buy, bring plenty of cool green cash because there's going to be a lot to spend it on.

SP Yard Tour

PCR CAJON DIVISION AUCTION AGREEMENT

- 1. This auction committee reserves the right to handle the auction and all matter concerning the auction as it sees fit. It further reserves the right to reject any item without stated cause.
- 2. Any matter regarding the auction should be brought to the auction chairman's attention; however, all matters shall be up to his judgement.
- 3. Once your items are entered into the auction, the item, or items cannot be removed until the item is either sold or rejected as a "no-bid" item.
- 4. All sales must be handled through the auction committee and the cashier.
- 5. Items will be auctioned off by number sequence, unless the auction committee representative elects to do otherwise.
- 6. It is agreed that the seller shall pay 10% of the selling price to the auction committee; this 10% fee shall be deducted from the selling price of the item.
- 7. Buyer shall pay for his purchase before the seller receives his money.**
- 8. Bid shall advance by amounts to be determined by the Auctioneer.
- 9. Each item shall be called three times before being sold. Items will not be described in detail.
- 10. At completion of sale, item will be forwarded to cashier who will collect the amount agreed upon before delivering purchase to buyer.
- 11. All items must be mounted on a temporary cardboard sheet for handling, or enclosed in an open top box. All items must be of a minimum five dollar value each or a lot value minimum of five dollars.
- 12. All items or monies due the seller must be claimed no later than the close of the auction.
- 13. Neither the auction committee nor the Cajon Division-PCR, assumes responsibility for condition or truthfulness of fact of any item.
- ** Only local checks made out to "Cajon Division/PCR" will be accepted. All checks must be approved by the Auction Committee and must be substantiated by driver's license identification. If the buyer pays by check the seller will be reimbursed by a Cajon Division check.
