From the Desk of the Director

Gary Stenberg, Cajon Division Director



Greetings from the Pacific Southwest Region. A lot has happened and there are a lot more things happening. On September 3rd the PSR held its regular business meeting. The major highlight of the meeting was, of course, the installation of me as the Cajon Division Director. Just kidding. I was officially recognized, but the business of the region was what the meeting was all about. Each of the four division directors presented a report from their division in addition to the reports from the other regional officers. Finances, meets, membership, and events in each division were reported on. Besides the Division reports, we also had reports presented on the health and well-being of the Region.

FINANCE: The region is financially healthy. The first six months of the year (Jan 1, 2025 through June 30th 2025) show the PSR, including all of the Divisions' accounts, with cash on hand of \$77,797.49. Expenditures for this period exceeded income by \$748.86. This shortfall will probably be overcome by the end of the year. A lot is going on with our finances as the Region and the Divisions are now included in one umbrella (501c3) tax deductible corporation. The treasurer has to file a bunch of paperwork, but our position is strong.

<u>MEETS:</u> All of the divisions held at least one "meet" during the first six months of the year. The Cajon Division hosted the biggest meet this year...that being the Pacific Southwest Region Convention at the Irvine Hilton, right next to John Wayne airport. A bit more information on the Convention will be presented later.

<u>MEMBERSHIP:</u> The good news for the region is that you are most likely a member. The bad news is that we have lost 76 members, region wide, from July 2024 until July 2025. The Cajon Division lost 12 members during this time. Our Division is looking into why we lost those members and what we might do to encourage new members joining and current members staying.

<u>ACHEVEMENT PROGRAM:</u> From the national convention held in Long Beach to the regional convention held in Irvine a total of 20 Achievement Program certificates have been awarded. One Master Model Railroader certificate was also awarded. In 2023-2024 we had 25 Achievement Programs certificates awarded and two Master Model Railroader certificates. Carl Heimberger MMR, the Region A/P chair, is researching methods to encourage participation in this program.

EVENTS: Things are happening all over the Region. The Arizona Division had their first annual "Cactus Crawl" that showcased 21 open house layout tours over two days. The Cajon Division hosted the regional convention. The LA Division continues to host the "Roundhouse Chats" on ZOOM the first Thursday of each month. The San Diego Division holds monthly in person activities. Lots going on. Keep your eyes peeled for something near you.

THE REGIONAL CONVENTION: The Pacific Southwest Region has a convention every year. This year the convention was held in Irvine. Unfortunately the attendance was down from previous conventions and, although we ended up in the "Black" we didn't generate a lot extra funds for the Cajon Division and the region. Perhaps the location was sub-optimal, since we had just had a National Convention in Long Beach, or perhaps it was higher priced than folks wanted to pay. Our next PSR convention is going to be held in San Diego (https://www.sandiegodivision.org/index.php/convention-2026). We haven't been there in four years and there are some spectacular things planned. So we, from the Cajon Division, need to be there and participate. Start building models now! The more models we enter, the better. Let's show the Region what the Cajon Division can do. The 2026 convention is in San Diego. The 2027 convention is going to be in Arizona. 2028 will find us in Los Angeles. In 2029, it's going to be the Cajon Division's turn to host. Let's make the convention that we will host in four years super outstanding.

WHAT'S UP: Getting back to the subject of membership, and thanks to Patrick Rogan our membership chair, we've learned that the membership in the inland empire wasn't being served adequately. Over the past several years virtually all of our meets have been in Buena Park. Buena Park is on the western edge of our division and was a popular site for both Orange County members and LA Division members. The venue was also convenient because one of our members, Annette Palmer, was a congregant at the church and helped coordinate the events. Half of our membership resides outside of Orange County, in points east, and that presented a problem to be solved. Well, we will be searching for an appropriate venue, or venues, somewhere in the inland empire for some of our future meets. Hunter Park with the Riverside Live-Steamers, the Southern California Railway Museum in Perris, and Community Centers have all been suggested and are being explored. If you know of a facility that can accommodate 100 to 120 people and has a large dining room and smaller break out rooms, please let us know.

Well that's about it for now. PAX and High Green!

Notes from the Chief Clerk

Editor's Note: With the appointment of Gary Stenberg to Division Director, Steve Cole has graciously agreed to assume Gary's old position of Cajon Division Chief Clerk. Below is Steve's biography in his own words. Welcome Steve!

I'm a life-long model railroader, starting with a Johnson-Russell 2-rail O gauge set around 1950. Santa really got it going with American Flyer in 1952. By junior high school I moved to HO with a Mantua Shifter, and over the next few years I built two 4 x 8 layouts in my parents' home. Thru college years and after Army time I kept up with the hobby by continuing to build rolling stock. Nearly 40 years ago I started building a HO layout that hangs in my garage. It is still not operational although the hard part (benchwork and handlaid mainline) is long done. I had hit a mental block and it stayed dormant for 30 years. Several years ago, I rejoined NMRA, exactly 50 years after I had previously been a member. That allowed me access to local modelers and I made contact with Gary Butts and the group that operates with him. With his very helpful knowledge and skills I'm back on track to get my layout going. That's what NMRA is all about. My personal emphasis within the hobby is model building, e.g., craftsman kits and scratch. I am also active with the Southern California S Gaugers Club, having both S scale and American Flyer Hi-rail trains on our modular layout at shows.

Mike Pacillo hosted a Hobo's meet up and open house layout tour of his N Scale Freelance Modular RR in Las Vegas, NV on Saturday, October 25. Mike provided the following summary.

The modules have three prototypical locations:

- 1. Horseshoe Bend (BNSF Mains in Yorba Linda, CA)
- 2. CSI California Steel Industries (NUCOR), Fontana, CA (the old Kaiser Steel Mills)
- 3. A two trestle scene from Afton Canyon

Motive power and rolling stock generally represents the 1990's BNSF with a side of Union Pacific. Many of the engines and rolling stock are weathered.

The CSI Peninsula is an industrial spur, designed and made to facilitate industrial operations at large FreemoN layouts which are running "Operations". It is a work in progress and reflects how the plant was configured in the 1990's and consists of four 24"x18' sections.

Afton Canyon is 100% complete (18"x6'). It's scenery represents a contemporary depiction of the location.

Horseshoe Bend is a 90° (four section) module, with 12' radius double track mains and a passing siding. It's a bit of an anachronism as far as time period goes. Full scenery reflects April 1972 Santa Ana Canyon with rolling hills covered in blooming mustard beauty. The three tracks (concrete ties) resemble the late 90's while the riverbed itself resembles how things looked in the 1950's. I'm super proud of Horseshoe Bend. It's often a crowd pleaser and a favorite among Free-moN operators at the shows where it appears.



What is That???

I came across this crazy oddity and thought it might be of interest. Inland Lime and Stone was a subsidiary of Inland Steel and located at Port Inland in Michigan's Upper Peninsula on the north shore of Lake Michigan. It was the primary source of limestone for Inland's steel making plants south of Chicago. Limestone was quarried and processed at the Port Inland facility and shipped by lake boat to the mills.

From US Dept of Interior Report Mining and Milling Methods, Inland Lime and Stone Co., Port Inland, MI by L.G. Marshall: "...Each train consists of a Differential Steel Car Co., 1,000 hp., trolley-type DC electric locomotive and nine 50-ton side dump cars. The power is picked up from the trolley line by a contact shoe at the lop side of the cab (Figure 10). The cab and power plant utilize only a small part of the locomotive chassis, the remaining space being occupied by a 40-ton side-dump box. This is loaded in the same manner as the regular cars and increases locomotive traction on the load haul." Figure 10 shows the locomotive and Figure 14 shows the car dumper. Trains are loaded in the quarry by an electric shovel, then taken to the processing building and dumped.

The quarry was still in operation as of 2021, but the quarry locomotive is no longer powered off overhead wire, but is a 'dummy' and a standard locomotive is used at the end of the train. See the You Tube video link on the next page.

From the same report, a map of the lime quarry is shown below. From my best investigation, the quarry lay along the original Soo Line which was purchased by Canadian Pacific. Subsequently CP sold the line to Wisconsin Central who was in turn bought by Canadian National, the current operator. Inland Steel was merged into other concerns years ago and other companies have taken over operation of the quarry.




FIGURE 1. - Location of Mill and Quarry, Inland Lime and Stone Company, Port Inland, Mich.
