

Soon afterward, it was converted to simple. 464 was retired from active service in 1962 from the D&RGW. 1973 saw this engine moved from Colorado to Buena Park. Knott's Berry Farm has purchased this engine and hopes to put her into service sometime this summer.

The Fall BOD meeting was held this year in Santa Maria. A very interesting "Mini" was put on by the people in this area with an excellent group of layout tours and their usual top-notch banquet.

A number of items were on the BOD agenda. Approval was given for the purchase of a new adding machine and dry copy machine for the Secretary. An increase to 75% was approved for FCR patches due

to higher costs.

A new committee was formed for the preservation of films and slides by the PCR. Each division will provide a member of this committee which is chaired on an interim basis by Ezra Goff, Redwood Empire Director. This committee, once formed, will then decide on a course of action for presentation to the Board for necessary funding. Anyone interested in volunteering for a position on this committee, please contact the Division Superintendent or myself.

PCR President Jim Sheets announced the appointment of Eric Bracher to the chairman's position of the re-enacted Public Relations Committee. Each division will furnish a member on this committee.

Again, we are looking for volunteers for this position.

A new set of By-Laws for the PCR was presented by the By-Laws Committee. After a complete reading, much discussion and some amending by the Board, these were tabled in order to allow the membership to look them over. Some of the changes are in wording for conformance to State requirements for a corporation. Other changes are, however, more basic and change the method of selecting the PCR officers. Also included is a means of more directly involving the division in PCR affairs by having an assembly where the division superintendents meet with the directors before each meeting. (Our Director does this already. Ed.) Copies of the proposed By-Laws are available in a limited quantity for those interested, from either the Division Superintendent or myself. We will also have copies available for reading at the Division Banquet in February. I would greatly appreciate hearing any comments or suggestions you may have on this matter.

A proposal was made by this Director for PCR funding of each division for the purpose of membership solicitation. This matter was referred to the Membership Committee for consideration.
