


- ·, Friday Night Bingo





We had three Judges: Ted Johnson; Ed Hall, MMR; and Brian Block, MMR.

I have received quite a lot of feedback about the contest and judging in general. This has

stimulated discussion between me and the Division leadership, and that's good, because that is the way we all learn. At regional and national meets where judging is done, there are at least five judges, each handling one of the categories on the entry paperwork. Many times, there are five teams of judges. In my tenure as AP/Contest Chair, we have not had that luxury. In fact, it is sometimes hard to get two because of personal commitments, illness, and other things. This can cause problems as it takes a long time (four hours at Barstow) and gets to be a real chore. So, and here comes the big ta-da, we would like to establish a cadre of at least 10 judges in the Cajon Division. So, I appeal to you! If you would like, or even wonder what it would be like, to be a judge, please contact me. And, just because I know some folks are a little shy, if you know somebody who you think would be a good judge, please submit their names to me. I'll take it from there. You do not have to be an MMR, just have some experience and have built some things. Photo judges are needed, too. I already have a couple of volunteers. I am developing a clinic that will give in-depth training on the NMRA Judging Guidelines. I will probably test run it at the January Las Vegas meet and give it at about every meet thereafter until we get our judging staff full.

One of the five areas at which judges look at is *conformity*. This is probably the most misunderstood category. There is an excellent article in the December 2007 Scale Rails entitled *A History of the NMRA Achievement Program* (1961-2007) by C. J. Riley, MMR, *et al.* that I urge you all to read. It starts on page 52 and in the middle of page 53 there is an interesting discussion about how the conformity category came about and what is now expected from the modeler. I think that this will help you in your model building and contest entering.


The attendance exceeded the previous year by 100 percent with almost 70 members and non-members attending the event.
